DILUTION

Daily cleaning as ready to use degreaser:

- RATIO-MIX Bottle: 750 ml trigger, dilution letter E.
- RATIO-SHOT Bottle: 750 ml trigger, dilution ring on 21 ml. 2 pumps for trigger.

Maintenance cleaning as ready to use degreaser:

- RATIO-MIX Bottle: 750 ml trigger, dilution letter K.
- RATIO-SHOT Bottle: 750 ml trigger, dilution ring on 9 ml. 1 pump for trigger.

Daily cleaning as degreaser for floors:

- RATIO-MIX Bucket: 8 L bucket, dilution letter J.
- RATIO-SHOT Bucket: 8 L bucket, place the dilution ring on 22 ml. 1 pump for bucket.

Maintenance cleaning as degreaser for floors:

- RATIO-MIX Bucket: 8 L bucket, dilution letter L.
- RATIO-SHOT Bucket: 8 L bucket, place the dilution ring on 10 ml. 1 pump for bucket.
