### HOW TO USE

- Floors: apply the CUAT NEXT solution with a mop or rag. Leave the solution acting for required timing, then rinse-off with water.
- Other washable surfaces (workbenches, sinks, walls and shelves, cold stores, etc): apply the solution with a sponge, leave acting for the required timing, then rinse-off with water.



### DILUTION

**Bactericidal Efficacy** (Standards EN 1276, EN 13697): dilution: 3% (30 ml of product for 1 L of water); contact time: 5 minutes; water temperature: 40°C. For specific efficacy against *Salmonella typhimurium*, apply a contact time of 15 minutes.

**Yesticidal Efficacy** (Standards EN 1650, EN 13697): dilution: 3% (30 ml of product for 1 L of water); contact time: 15 minutes; water temperature: 20°C.

**Fungicidal Efficacy** (Standards EN 1650, EN 13697): dilution: 5% (50 ml of product for 1 L of water); contact time: 15 minutes; water temperature: 20°C.

**Virucidal Efficacy:** (Standard EN 14476+A1, H1N1): dilution: 5% (50 ml of product for 1 L of water); contact time: 5 minutes; water temperature: 40°C.
