PER ACTIVE is an active oxygen and peracetic acid-based disinfectant\* agent, with a bactericidal and fungicidal action. Can be added to the washing machine, at medium and low temperatures. Suitable for all kind of fabrics, except wool and nylon. Use with automatic dosing system.

**COMPOSITION** (Reg. 648/2004/EC): oxygen based bleaching agents > 30%. Surfactants free, phosphates free. Auxiliary for fabrics washing. **CHEMICAL COMPOSITION:** 100g of product contain: peracetic acid 4,8g, hydrogen peroxide 27,9g, Coformulants and water i.e. 100g.

To be used with the other products of the Oxipur range, and with Sutter Tech automatic dosing systems.



## PER ACTIVE

### DILUTION

To be dosed according to the cycle of washing, water hardness and kind of dirt. Optimised for use with Oxipur system products and with Sutter Tech automatic dosing systems.

To combat bacteria and yeast, dilute to 0.2% (2 ml per liter of water). Action time: 5 minutes. PER ACTIVE is active from 20 °C.

To combat bacteria and fungi, dilute to 0.6% (6 ml per liter of water). Action time: 15 minutes. PER ACTIVE is active from 40 °C.
